

The Pharmacy Act 1948 was enacted on 4.3.48 with the following preamble- "An Act to regulate the profession of pharmacy. Whereas it is expedient to make better provision for the regulation of the profession and practice of pharmacy and for that purpose to constitute Pharmacy Councils". The PCI was constituted on 9.8.49 under section 3 of the Pharmacy Act.

The main objective of the PCI is the Regulation of the Pharmacy Education in the Country for the purpose of registration as a pharmacist under the Pharmacy Act, and Regulation of Profession and Practice of Pharmacy.

About AICTE: The AICTE was constituted in 1945 as an advisory body in all matters relating to technical education. Even though it had no statutory powers, it played a very important role in the development of technical education in the country. It had four regional committees with offices at Chennai, Mumbai, Kanpur and Calcutta.
