(Government & Non-Government Grants & Funding)

NOTICE

All Faculty members are hereby informed that to work upon Research Grants and Funding from Government and Non-Government Agencies for a State-of-Art Research Work, Policy is implemented as per following rules and regulations:

Eligibility:

- Faculty member must take prior approval from R&D Cell and obtain the Approval or forwarding letter from the R&D Head. Copy of the proposal has been submitted in the IQAC.
- 2. Acknowledgement of the final submission of the project and a copy of the proposal should have been submitted to the R&D Head.

Term & Conditions:

- 1. Amount will be equally divided among all the faculty members associated with the Project and same will be disseminated at the end of Academic Year based upon the progress of Project and Grant Received.
- For any research activity, which is done in collaboration with other Institute / Lab or University, only the faculty member of Arya College of Pharmacy shall be entitled for Research Awards or Cash Incentives. The external member shall not be entitled for any benefits.
- 3. Incentive Amount for Research Project Grant: An amount equal to fixed % of the funding amount credited into the Institute Account. The percentage will be recommended by Committee every year depending upon the total amount of funding received in that calendar year.
- 4. If even after disbursement of the incentive, if the awardee is found supplying wrong, incorrect, or incomplete information, whole amount of cash incentive will be reclaimed back.

NOTICE

All Faculty members are hereby informed that with the objective of promotion of Research Publications in reputed Journals & Conferences and to increase Quality Research and Start up, following Incentives are allowed to disburse after submission of relevant applications.

Publication in	Incentive Amount per paper (in INR)
Indexed Journal (SCI/ SCIE/ Scopus/ ESCI/ Web of Science)	Rs. 2500/- + One Day Paid Leave (OD)
Indexed Journal (Listed in UGC Care)	Rs. 2000/- + One Day Paid Leave (OD)
Indexed Conference (IEEE / Springer etc.) with ISBN	Rs. 1500/- + One Day Paid Leave (OD)

Eligibility / Terms & Conditions:

- 1. Only Faculty members associated with Arya College of Pharmacy and paper should be in name of Arya College of Pharmacy only.
- 2. Irrespective of no. of authors in the paper, Only Author & Co-Author will be eligible for Incentives.
- 3. M.Pharma. Fellowship Students / Ph.D. Students / UG Students will not be eligible for any incentives.
- 4. No cash incentive will be payable to the authors from other institutes.
- 5. Papers with higher h-index will be considered for award of cash incentives.

Advantages:

- 1. Faculty members will be hesitating to add the names of non-deserving authors in their papers who have not contributed.
- 2. There will not be any conflicts among Faculty members on the amount of cash incentives to be given away to authors / co-authors.
